Questions and statements

The following questions and statements were made by those present:

1. Mr Spannagle – during the workshop in February, it was resolved to assist Greater Hume Council with work on the Henty Showground fire connection. This work has been undertaken and was completed this week.
2. Mr Crakanthorp – At the February meeting, the Board resolved to complete a customer survey, this survey is proceeding, and he thanked Emily and Josh for their work in preparing the survey. Council staff will be using survey monkey to conduct survey, using the same questions as the previous survey. This will allow comparison between the results of the last survey and this survey. The survey will be incentivised to encourage responses and there will be a competition in which customers can enter a draw to win a years worth of their water bills up to \$800. Staff are not eligible to enter. Survey will commence on Friday. Councillor Hayes enquired regarding what would happen if a renter wins? Ms Tonacia advised there are a set of complex terms and conditions for the competition and one of those conditions is you must be a registered owner to be eligible to win.
3. Mr Spannagle asked Mr Crakanthorp to provide a update on COVID-19 impact on general staffing issues that are currently being experienced. Riverina Water is currently being impacted significantly as virus spreads through the community. Arranged to have RATs available that can be provide to staff if they become symptomatic at work. If positive they need to self-isolate. It is becoming challenging to maintain normal staffing levels. Reminding staff to get boosters and be as cautious as they can. Continuing to isolate critical staff, currently finding staff are needing to isolate as close

contacts. Customer Service remains open at this stage. Councillor Hayes sought confirmation that water treatment plant operators are deemed essential workers and if necessary continue to work if deemed close contact, this was confirmed accurate. Councillor Hayes also asked if Riverina Water has looked into purchasing a HVAC to help in limiting spread of virus? Mr Crakanthorp advised that no this has not yet been considered and advised that it will be added to the Executive Management Team agenda for discussion at the next meeting.
